A BILL

To determine if Alfred Kinsey's "Sexual Behavior in the Human Male" and/or "Sexual Behavior in the Human Female" are the result of any fraud or criminal wrongdoing.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Child Protection and
3 Ethics I Education Act of 1995”.

4 **SEC. 2. FINDINGS.**

5 The Congress finds the following:

6 “Table 34” in Alfred Kinsey’s “Sexuality in the
7 Human Male” provides significant reason for the
8 Congress to require an in-depth study be performed
9 to determine if Kinsey and his fellow researchers
10 employed systematic sexual abuse of children to ob-
11 tain the data tabulated in “Table 34” and other por-
12 tions of the study.

13 **SEC. 3. STUDY BY GENERAL ACCOUNTING OFFICE (GAO) OF**
14 **WRONGFUL USE BY AGENCIES AND SCHOOLS**
15 **OF TAX MONIES TO PROMOTE ERRONEOUS,**
16 **FRAUDULENT INFORMATION ON SEXUAL BE-**
17 **HAVIOR BASED UPON THE KINSEY REPORTS**
18 **AND ITS DERIVATIVES.**

19 (a) IN GENERAL.—With respect to agencies, univer-
20 sities, or elementary and secondary schools that receive
21 Federal funds for educational purposes, the Comptroller
22 General of the United States shall conduct a study for
23 the purpose of determining the following:

24 (1) Whether programs, lectures, texts, or other
25 pedagogical materials involving sexuality (e.g., AIDS
26 Prevention, Family Life Education, Diversity Edu-

1 cation, Sex Education) used by such institutions sig-
2 nificantly or particularly rely on the scholarship of,
3 directly or indirectly consisting of, or based on the
4 studies entitled “Sexual Behavior in the Human
5 Male” and “Sexual Behavior in the Human Female”
6 authored by Alfred Kinsey and his team of research-
7 ers and published in 1948 and 1953 (“Kinsey Re-
8 ports”).

9 (2) The GAO may evaluate whether the con-
10 tents of the Kinsey Reports are erroneous and/or
11 wrongfully obtained by reason of fraud or criminal
12 wrongdoing (i.e., systematic sexual abuse of chil-
13 dren).

14 (b) REPORT TO CONGRESS.—Not later than May 1,
15 1996, the Comptroller General of the United States shall
16 complete the study under subsection 1 and submit to the
17 Congress a report describing the findings made in the
18 study.

19 **SEC. 4. KINSEY REPORTS; CONTINGENT PROHIBITION RE-**
20 **GARDING FEDERAL FUNDING FOR IMPLI-**
21 **CATED UNIVERSITY, COLLEGE, ELEMENTARY,**
22 **AND SECONDARY SCHOOLS AND RELEVANT**
23 **AGENCIES.**

24 (a) If the determination made by the Comptroller
25 General of the United States under paragraph 3(a)(2) is

1 in the affirmative, the Secretary of Education shall ensure
2 that, for fiscal year 1997, and subsequent fiscal years, no
3 Federal funds are provided to any agencies, persons, uni-
4 versities, or elementary and secondary schools for any edu-
5 cational purpose which instruct in Kinsey's work, and/or
6 derivative Kinseyan scholars and/or scholarship without
7 indicating the unethical and tainted nature of the Kinsey
8 reports. The chief executive officer of the State involved
9 shall certify to the Secretary which such agencies or school
10 programs cite said materials.
